Position Overview:

The Adaptive Climbing Coalition is seeking a dynamic and experienced individual to join the ACC as Programs Director. As Programs Director, you will play a pivotal role in shaping and implementing our organization's programs, initiatives, and clinics. The ideal candidate will bring a strong background in program development, strategic planning, and rock climbing.

Key Responsibilities:

Program Strategy and Planning:

- Collaborate with board members and staff to plan, develop, and refine the organization's programmatic strategies.
- Provide insights, expertise, and guidance to ensure the continuous improvement and innovation of existing programs, as well as the development of new, impactful initiatives.

• Program Development and Management:

- Lead discussions and contribute to decision-making regarding the prioritization of programmatic efforts, taking into consideration community needs, organizational capabilities, and available resources.
- Collaborate with other board members to communicate the impact and value of our programs to potential donors, supporters, and the broader community.
- Evaluate the effectiveness of programs through feedback collection and regular assessment, making recommendations for adjustments and improvements as needed.

Safety and Risk Management:

- Establish and enforce safety protocols, risk management procedures, and industry standards to ensure participant safety during all program activities.
- Collaborate with external experts and regulatory bodies to maintain compliance with relevant safety guidelines and certifications.

Support to Fundraising:

 Assist in the identification of potential funding sources and partnerships to support program development and sustainability.

• Organizational Responsibilities:

 Understand and adhere to ACC bylaws, standard operating procedures, DEI statement, and mission statement.

Qualifications:

- Strong commitment to the organization's mission and values.
- Proven experience in program development, preferably in a non-profit or community focused context.
- Previous experience serving on nonprofit boards or volunteering in a leadership capacity is a plus, but not required.
- Excellent strategic planning skills
- Effective communication and interpersonal skills
- Capacity to work as part of a team and contribute constructively to board discussions and decisions.
- Deep understanding of rock climbing.
- Certified in AMGA/ PCGI Single Pitch Instructor or greater.
- Desire to be certified in ACI, ACI-G, and ACI-M.
- Must be a resident of California, Arizona, Nevada, or Utah (exceptions allowed).
- Must be able to travel to weekend clinics in Joshua Tree (1-2 per year)

Time Commitment:

The Programs Director position requires a commitment of approximately 6-10 hours per month. This includes attendance at board meetings, preparation time, and any additional responsibilities as needed. As Programs Director you will serve up to a four-year term limit with the opportunity for additional term limits.
